GENERAL BUSINESS BILLS THAT PASSED

HB 139 by Hoffman, Frank(R)/Mizell(R) - 8- 1-18 G Effective (Act: 501)

Provides an exception with respect to certain telephonic solicitations during a declared state of emergency.

HB 155 by Stokes, Julie(R)/Martiny(R) - 7- 1-18 G Effective (Act: 120)

Increases the fees levied by the La. Tax Commission for assessment of certain properties.

HB 194 by Howard, Frank(R)/Long(R) - 8- 1-18 G Effective (Act: 66)

Provides a time period after payment of a claim during which an insurer may dispute and recoup the amount paid.

HB 341 by Abramson, Neil(D)/Morrell(D) - 5-10-18 G Effective (Act: 86)

Changes the due date for filing corporate franchise tax returns.

HB 406 by Jefferson, Patrick(D)/Riser(R) - 8- 1-18 G Effective (Act: 314)

Provides for an update to terms and technical corrections relative to unemployment compensation.

HB 429 by Cromer, Greg(R)/Long(R) - 1- 1-19 G Effective (Act: 208)

Provides relative to denial of claims for dental services.

HB 621 by Foil, Franklin(R)/Martiny(R) - 5-28-18 G Effective (Act: 560)

Provides relative to omnibus corporate filing regulations.

HB 669 by Marcelle, Denise(D)/Morrell(D) - 8- 1-18 G Effective (Act: 714)

Provides for a hold on the renewal of an operator's license under certain circumstances.

HB 748 by Emerson, Julie(R)Peacock(R) - 8- 1-18 G Effective (Act: 693)

Establishes the Occupational Licensing Review Act.

HB 754 by Foil, Franklin(R)/Fannin(R) - 5-28-18 G Effective (Act: 585)

Provides relative to certain veteran-owned small entrepreneurship.

SB 164 by Morrell(D)/Dwight, Stephen(R) - 11- 6-18 G Effective (Act: 718)

Constitutional amendment to authorize the phase-in of increases in ad valorem taxation under certain circumstances.

SB 177 by Walsworth(R)/Stokes, Julie(R) - 5-20-18 G Effective (Act: 363)

Authorizes the legislative auditor to obtain certain information about employees with access to federal tax records of auditees.

SB 204 by Smith(D)/Miller, Greg(R) - 8- 1-18 G Effective (Act: 652)

Provides relative to caller ID spoofing.

SB 239 by Morrell(D)/Abramson, Neil(D) - 7- 1-18 G Effective (Act: 527)

Authorizes the Department of Revenue to refuse to issue a resale certificate to a new business if the business reorganization was intended to evade payment of sales and use or withholding tax.

SB 260 by Milkovich(D)/Jenkins, Sam(D) - 8- 1-18 G Effective (Act: 655)

Provides relative to disciplinary hearings by professional and occupational licensing boards and commissions.

SB 336 by Riser(R)/Jefferson, Patrick(D) - 6-30-18 G Effective (Act: 380)

e-creates the Louisiana Workforce Commission and reauthorizes the Incumbent Worker Training Program.

SB 361 by Walsworth(R)/Carmody, Thomas(R) - 8- 1-18 G Effective (Act: 382)

Provides relative to the protection of computerized data that contains personal information and requires notification of data breaches.

SB 373 by Barrow(D)/Jackson, Katrina(D) - 8- 1-18 G Effective (Act: 667)

Provides for the required reporting of all revenue, exemptions, credits, and rebates on LaTrac.

SB 416 by White(R)/Carmody, Thomas(R) - 1- 1-19 G Effective (Act: 243)

Provides relative to the registration of investment adviser representatives.
