



## 2015 Regular Legislative Session

### **GENERAL BUSINESS BILLS THAT PASSED**

**[HB 120](#) by Shadoin, Rob, Martiny, Effective 8-1-15**

Provides relative to provisional notaries.

**[HB 131](#) by Berthelot, Johnny, Amedee, Effective August, 1 2015 - Act 50**

Provides that certain recalled elected officials are ineligible to become candidates in certain elections.

**[HB 233](#) by Adams, Bryan, Morrell, Effective 8-1-15**

Authorizes the permitting and operation of microdistilleries in Louisiana.

**[HB 285](#) by Montoucet, Jack, Riser, Effective 8-1-15**

Provides relative to fees established for certain structural pest control business owners.

**[HB 316](#) by Ponti, Erich, Martiny, Effective 8-1-15**

Provides relative to licensing fees for money transmitters.

**[HB 317](#) by Ponti, Erich, Martiny, Effective 8-1-15**

Provides relative to licensing fees for lenders licensed to make consumer loans.

**[HB 318](#) by Ponti, Erich, Martiny, Effective 8-1-15**

Provides relative to licensing fees for pawnbrokers.

**[HB 346](#) by Hoffman, Frank, Walsworth, Effective 8-1-15**

Provides relative to advertising by dentists.

**[HB 354](#) by Ponti, Erich, Martiny, Effective 8-1-15**

Provides relative to licensing fees for mortgage lenders, mortgage brokers, mortgage servicers, and mortgage originators.

**[HB 381](#) by Jackson, Katrina, Kostelka Effective May 29, 2015 – Act23**

Exempts certain providers from licensure as behavioral health services providers.

**[HB 385](#) by Landry, Nancy, Murray, Effective 8-1-15**

Provides with respect to mandatory reporters relating to health/social service practitioners.

**[HB 394](#) by Miller, Greg, Brown, Effective 10-5-15**

Provides relative to names of business entities, trade names, trademarks, and service marks.

**[HB 464](#) by Talbot, Kirk, Martiny, Effective 8-1-15**

Provides relative to franchise relationships.

**[HB 467](#) by Harris, Lance, Gallot, Effective 8-1-15**

Provides relative to the payment and purchase of tobacco products.

**[HB 468](#) by Landry, Nancy, White Effective August 1, 2015 – Act 24**

Provides relative to realtors and the duties of licensees representing clients.

**[HB 477](#) by Montoucet, Jack, Mills, Effective 8-1-15**

Provides for minimum pricing of cigarettes.

**[HB 518](#) by Stokes, Julie, Morrell, Effective 11-26-15**

Constitutional amendment providing for matters which may be considered in a regular session convening in an odd-numbered year.

**[HB 611](#) by Pylant, Steve, Cortez, Effective August 1, 2015 – Act 81**

Provides relative to net listing agreements relative to real estate.

**[HB 692](#) by Robideaux, Joel, Mills, Effective 6-29-15**

Provides relative to the Uniform Unclaimed Property Act.

Companions: HB 240 (Identical)

**[HB 743](#) by Foil, Franklin, Martiny, Effective See Act.**

Provides relative to the Business Corporation Act.

**[HB 772](#) by Burns, Tim, Crowe, Effective 8-1-15**

Provides relative to unemployment compensation appeals.



## 2015 Regular Legislative Session

**[SB 42](#) by Walsworth, Shadoin, Rob, Effective 6-29-15**

Provides for the procedure for notification for certain public contracts and requests for proposals.

**[SB 103](#) by Morrell, Talbot, Kirk, Effective 1-1-16**

Excludes certain expenditures as eligible for motion picture investor tax credits.

### **TAX BILLS THAT PASSED**

**[HB 218](#) by Broadwater, Chris, Kostelka, Effective 7-1-15**

Provides with respect to the net operating loss deduction for purposes of the corporate income tax.

**[HB 402](#) by Stokes, Julie, Adley, Effective See Act No. 109**

Adds requirements for eligibility for the income tax credit for taxes paid in other states.

**[HB 471](#) by Stokes, Julie, Riser, Effective 7-1-15**

Establishes the Sales Tax Streamlining and Modernization Commission to perform a comprehensive study of Louisiana's state and local sales and use tax systems.

**[HB 508](#) by Foil, Franklin, Broome, Effective 6-19-15**

Authorizes an income tax deduction for taxpayers who employ certain qualified disabled individuals.

**[HB 664](#) by Stokes, Julie, Adley, Effective 1-1-16**

Defines "inventory" for purposes of the tax credit for ad valorem taxes paid on inventory.

### **REGULATORY BILLS THAT PASSED**

**[HB 241](#) by Barras, Taylor, Perry, Effective 7-1-15**

Provides relative to the distribution and sale of certain public documents by the Secretary of State.

**HB 466 by Barras, Taylor, Walsworth, Effective 6-19-15**

Provides for the eligibility of businesses to participate in the Enterprise Zone Program.

Companions: HB 280 (Very Similar)

**HB 741 by Williams, Alfred, Crowe, Effective 8-1-15**

Provides relative to workforce development and the Workforce Investment Council.

**SB 101 by Morrell, Talbot, Kirk, Effective 7-1-15**

Requires the Louisiana Workforce Commission to provide information to LED and LDR to verify payroll and employment of Louisiana residents for purposes of the motion picture investor tax credit.
