



## 2016 REGULAR LEGISLATIVE SESSION

### **GENERAL BUSINESS BILLS THAT PASSED**

**[HB 142](#) Miguez, Blake(R), Ward(R), Effective August 1, 2016 – Act 212**

Provides with respect to eligibility requirement for concealed carry permits.

**[HB 208](#) Bishop, Stuart(R), Martiny(R), Effective May 26, 2016 – Act 243**

Provides relative to home service contract providers.

**[HB 212](#) Davis, Paula(R), Bishop(D), Effective August 1, 2016 – Act 102**

Requires employers to report pending lump sum payments to employees to appropriate enforcement agencies, all related to child support.

**[HB 223](#) Landry, Terry(D), Carter(D), Effective August 1, 2016 – Act 543**

Provides with respect to illegal carrying of weapons.

**[HB 266](#) Marcelle, Denise(D), Long(R), Effective August 1, 2016 – Act 398**

Prohibits certain questions regarding criminal history during the employment process for certain positions.

**[HB 286](#) Garofalo, Ray(R), Perry(R), Effective August 1, 2016 – Act 544**

Provides for revisions to the Trust Code and the treatment of interest upon death of the principal beneficiary.

**[HB 289](#) Garofalo, Ray(R), Ward(R), Effective August 1, 2016 – Act 89**

Provides with respect to a corporation's juridical personality at the termination of corporate existence.

**[HB 570](#) Schroder, John(R), Claitor(R), Effective August 1, 2016 – Act 630**

Provides relative to the practice of telemedicine.

**[HB 624](#) Moreno, Helena(D), Morrell(D), Effective August 1, 2016 – Act 124**

Provides with respect to the reporting of certain judicial proceedings regarding the possession of firearms.

**[HB 637](#) Stokes, Julie(R), Martiny(R), Effective August 1, 2016 – Act 61**

Authorizes the imposition of certain fees for rental of automobiles.

Provides relative to distribution of alcoholic beverages.



## 2016 REGULAR LEGISLATIVE SESSION

**[HB 680](#) Moreno, Helena(D), Thompson(D), Effective June 2, 2016, Act 311**

Requires healthcare services providers to conduct background checks on prospective employees.

**[HB 710](#) Hollis, Paul(R), Martiny(R), Effective August 1, 2016 – Act 640**

Changes the time period in which cigarettes must be stamped.

**[HB 714](#) Foil, Franklin(R), Claitor(R), Effective August 1, 2016 – Act 442**

Provides relative to the Business Corporation Act.

**[HB 798](#) Talbot, Kirk(R), Johns(R), Effective August 1, 2016 – Act 258**

Provides for limited lines licensing to sell property coverage for property that is selfstored in selfstorage facilities.

**[HB 806](#) Abramson, Neil(D), Martiny(R), Effective February 1, 2017- Act 147**

Provides relative to the dissolution of limited liability companies.

**[HB 830](#) Seabaugh, Alan(R), Peacock(R), Effective August 1, 2016 – Act 646**

Provides relative to criminal background checks for owners, employees, volunteers, and inspectors of early learning centers.

**[HB 862](#) Falconer, Reid(R), Hewitt(R), Effective August 1, 2016 – Act 226**

Provides relative to the liability of certain persons for the actions of persons with developmental disabilities.

**[HB 1142](#) Horton, Dodie(R), Peacock(R), Effective August 1, 2016 – Act 463**

Provides for unemployment compensation for military spouses who resign employment to relocate pursuant to a permanent change of station order. Substitute for HB 941.

**[SB 58](#) Martiny(R), Stokes, Julie(R), Effective August 1, 2016 – Act 327**

Repeals certain requirements relative to home service contract providers, including requirements for the submission of documentation to the secretary of state.

**[SB 91](#) Colomb(D), Marcelle, Denise(D), Effective August 1, 2016 – Act 472**

Increases penalties for texting or using social media while driving.

**[SB 251](#) LaFleur(D), LeBas, Bernard(D), Effective August 1, 2016 – Act 532**

Prohibits certain WiFi "hotspot" blocking.

**[SB 291](#) Mills(R), LeBas, Bernard(D), Effective June 6, 2016 – Act 396**



## 2016 REGULAR LEGISLATIVE SESSION

Provides for patient access to physical therapy services without a prescription or referral from a physician.

**[SB 468](#) Johns(R), Leger, Walt(D), Effective August 1, 2016 – Act 395**

Prohibits establishments that sell alcoholic beverages from employing persons under twenty one years of age for certain purposes. Substitute for SB 191.

### **INSURANCE BILLS THAT PASSED**

**[HB 694](#) Moreno, Helena(D), Gatti(R), Effective May 19, 2016, Effective August 1, 2016 – Act 145**

Provides relative to required coverage for reconstructive surgeries following mastectomies.

**[HB 782](#) Davis, Paula(R), Smith(R), Effective August 1, 2016 – Act 32**

Provides relative to certain definitions in the Insurance Code used in regulation of health insurance.

**[SB 95](#) Ward(R), Brown, Chad(D), Effective August 1, 2016 – Act 197**

Provides relative to evidence of compulsory motor vehicle insurance.

**[SB 258](#) Luneau(D), Carmody, Thomas(R), Effective August 1, 2016 – Act 206**

Provides for coverage for refills for prescription eye drops.

### **TAX BILLS THAT PASSED**

**[HB 735](#) Abramson, Neil(D), Claitor(R), Effective August 1, 2016 – Act 661**

Provides relative to the deadlines for the payment of certain taxes and the time and place for the filing of certain income tax returns.

**[HB 783](#) Abramson, Neil(D), Walsworth(R), Effective August 1, 2016 – Act 663**

Relative to the Louisiana Quality Jobs Program tax rebates.

**[HB 1120](#) Schroder, John(R), Peterson(D), Effective August 1, 2016 – Act 568**

Creates the Louisiana Tax Institute within the Dept. of Revenue as an advisory body on tax related matters.

**[SB 99](#) Smith(D) Miller, Greg(R), Effective August 1, 2016 – Act 198**

Provides relative to sales by minors relative to occupational license taxes.

### **REGULATORY BILLS THAT PASSED**

**[HB 284](#) Foil, Franklin(R), Martiny(R), Effective August 1, 2016 – Act 107**

Provides relative to the Business Corporation Act and grace periods for annual reports.

**[HB 312](#) Davis, Paula(R), Smith(R), Effective August 1, 2016 – Act 45**

Reconstitutes the Louisiana Mandated Health Benefits Commission and eliminates the requirements for periodic reevaluation of and a moratorium on such mandates.

**[HB 756](#) Abramson, Neil(D), Appel(R), Effective August 1, 2016 – Act 446**

Requires the electronic filing of certain claims for refunds.

**[HB 737](#) Abramson, Neil(D), Appel(R), Effective August 1, 2016 – Act 662**

Changes the deadline for the submission of annual reports to the Department of Revenue regarding deductions and withholdings of employee wages.

**[HB 876](#) Leger, Walt(D), Martiny(R), Effective August 1, 2016 – Act 554**

Provides for certain commercial filings to be submitted electronically.

**[HB 1121](#) Leger, Walt(D), Carter(D), Effective August 1, 2016 – Act 569**

Establish notification and reporting requirements relative to retail sales made in Louisiana by remote retailers.

**[SB 145](#) Martiny(R), Carmody, Thomas(R), Effective August 1, 2016 – Act 75**

Repeals certain provisions of the Sale of Checks and Money Transmission Act.
